The mare is booked specifically by name and registration number. The booking is valid to the

mare named and may not be transferred without consent of the stallion owner or manager. This contract to the above mare cannot be sold by mare owner.

No mare shall be bred until stallion contract is returned and breeding fess are paid.

Collection of semen for shipment will occur Mondays, Wednesdays, and Fridays throughout the designated breeding season. Shipment will be by priority overnight FedEx. Semen availability will be on a first come first serve basis and the mare owner may not receive more than 6 semen shipments during a regular breeding season.

Breeding Season is from March 1 through August 31.

The Stallion Owner reserves the right to exhibit the stallion at certain horse shows during the breeding season. Semen will not be available at these times. The stallion's show schedule is available by calling (269) 838-6473.

If the mare fails to produce a live foal (DEFINED AS ONE THAT STANDS AND NURSES WITHOUT ASSISTANCE WITHIN 24 HOURS OF BIRTH) a written statement from a qualified Veterinarian within one (1) week from death must be provided to the stallion owner or manager.

Privileges are guaranteed the following year if the Stallion is living, accompanied by a \$500.00 carry over re-breed fee. In the event the Stallion is unfit to service the mare from disability, castration or death, this contract shall become null and void and NO frozen semen will be made available to the mare owner.

Neither the stallion owner, manager, farm, nor it's members or employees shall be liable for injury, death, or disability suffered by the mare and/or foal, from any cause whatsoever while in the custody of Trotwood Farm. The mare owner specifically assents to such condition and waives each and every claim for damages resulting from such injury, death, or disability.

All charges including transportation, board, veterinarian fees, as well as any and all related medicines or medical supplies, etc. Are to be paid promptly by the mare owner.

The mare owner is responsible for safe and complete return of all equitainers and its contents used during fresh cooled semen shipments. A \$25.00 per day late fee will be charged for any equitainer not in Trotwood Farm's possession within 3 working days of mare owner receipt. A \$50.00 per day late fee will be charged for any equitainer not in Trotwood Farm's possession within 5 working days of mare owner receipt.

Trotwood Farm reserves the right to reject any mare not in good physical condition.

Include a copy of registration papers for mare to be booked. If mare is a National Champion or Reserve National Champion proven record of win must be included with registration papers.
